# What Does Your Church **Believe About Marriage?**

A Message from The Rev. Jim Barnes, National Minister

She found our church in a phone book and showed up on a weekday with her tape measure. When I asked the young woman what she needed, her answer was, "I'm looking for a church to

get married in and I want to measure your building to make sure my wedding party will fit up front." I then attempted to redirect her into a discussion of what it would mean to have a Christian marriage ceremony in our church, but she was firmly resolved to go into the sanctuary and take measurements - so I let her go.

After the bride-to-be had completed her analysis of our building, I talked with her for a while, explaining what our church believed about the nature of Christian marriage. I then handed her a copy of our church's wedding policy, told her to read it with her fiancé and then call back if she wanted to move forward. I didn't hear from her again, nor did I hear from any lawyers complaining that our wedding policy discriminated

against people who wanted to marry in our church who were not prepared to affirm our statement of faith, attend worship regularly and agree to practice abstinence and stop living together if they were already cohabiting prior to the wedding day (which were all written requirements for a ceremony in our church).

My assumption is that either our church didn't measure up, or, the religious convictions regarding faith, worship and sexual behavior expressed in our wedding policy were not acceptable to this particular bride and groom. Regardless of their reasons for not pursuing a ceremony at our church, at least this couple respected our right to have policies based on our religious convictions which they would need to abide by if they chose to have their ceremony in our building. I wonder if their response would have been the same these days?

In recent years, florists, bakers, photographers and the proprietors of wedding chapels and other venues have been challenged and in some cases sued if they refuse to provide services that violate their deeply held religious convictions regarding the nature of marriage. While some believe churches would be exempt from such attacks if our society changes its definition of marriage, the question is, will the right to the free exercise of religion guaranteed by the U.S. Constitution be able to hold up against the newly perceived rights people believe they have to unrestrained sexual expression and the practice of gender fluidity?

I recently attended a meeting of the Common Ground Christian Network on the theme of religious freedom (see article on page one). A featured speaker was constitutional and church law attorney Scott Ward who suggested that many churches are unprepared for what may be coming if the Supreme Court rules against natural marriage later this year. Ward stated, "The best way to protect your rights will be to clearly articulate your religious identity in all important organizational documents."

Since most of the churches affiliated with the Evangelical Association are independent, the question I would ask is, "Has your

church taken the time to clearly articulate what it believes about Christian doctrine and morality?" If your church's right to the free exercise of religion eventually does come under attack, it will be very important that congregations have taken the time to state what their religious convictions are and why they hold those convictions.

Furthermore, if your congregation is part of the Evangelical Association, you need to make sure your affiliation is current since each year a church belongs to the EA is another year that they have gone "on the record" as affirming the religious belief that marriage is the union of one man and one woman. Since the EA keeps a record of signed renewal forms, we have the paper trail your church might need at some point to prove your position on these matters.

Back when the congregation I served created their first written wedding policy nearly fifteen years ago, we never anticipated the changes to the definition of marriage that would happen in our society just a decade later. At the time, some in our church even thought we were putting things in writing that were **so obvious** that we were actually being **overly cautious**. In hindsight, it's clear that in order to adequately articulate the beliefs of an orthodox, evangelical church, that policy probably needs a few more paragraphs!

#### I Believe in the Church

In spite of her imperfections, I believe in the church—I really, really do! There is nothing like the local church when it's working right. In the words of Pastor Bill Hybels:

"Its beauty is indescribable. Its power is breathtaking. Its potential is unlimited. It comforts the grieving and heals the wounded and the abused in the context of community. It builds bridges to seekers and offers truth to the confused. It provides resources for those in need and opens its arms to the forgotten, the downtrodden, the disillusioned. It breaks the chains of addictions, frees the oppressed, and offers belonging to the unwanted. Whatever the capacity for human suffering, the church has a greater capacity for healing and wholeness." No other organization on earth is like the church.

In spite all of her flaws and shortcomings, I believe in the Church—I believe in the local church—and that includes the churches of the Evangelical Association!

Our journey in Christ was never meant to be a solo adventure—we were meant to be "networked". Scott Peck wrote: "We can never be completely whole in and of ourselves. We are inevitably social creatures who desperately need each other—not merely for company but for any meaning to our lives whatsoever." The New Testament Church did a great job of realizing that we must be a family on a mission rather than just a collection of acquaintances. Truth of the matter is that we were created to have relationships. God said, "It is not good for the man to be alone." And when Jesus sent out His disciples, He sent them out two by two. The church was not meant to be a building, but to be a family that collectively builds the church.

How do we build the church? As a family, we gather others. We are called to reproduce ourselves by bringing others to Christ. As a family, we are called to give life. If you have Christ in your life, then you have eternal life—eternal life means that you will never die! Doesn't that excite you?! It should—and we should be excited enough to share it. As a family we encourage one another. We should develop the kind of a relationships

the freedom of minority religions to even exist in many countries is now in question. Juliana Taimoorazy, an Assyrian Christian who escaped persecution in her native Iran talked in great detail about the current persecution occurring in Iraq and other areas with historic Christian minority populations where believers are literally being killed or forced out of their homes and villages for identifying with Christ.

Frank Wolf, a retired congressman, shared the story of a Christian husband who attempted to take his wife of 28 years to Mosul for her breast cancer treatments after ISIS had seized the city. When they arrived at the hospital, they were met by a guard who refused to allow them in because they were Christian. They were told that the price for entrance and medical treatment was conversion to Islam. The wife responded, "I am not going to leave the cross of Christ. I will not abandon it. For me, a love of life is not as important as the faith. The desire to go on living is not as important as my faith." The couple, a construction worker and his wife, returned to their small village. Ten days later, the 45 year old mother passed away with her husband and two sons, ages 19 and 8 at her side.

Throughout the two day meeting of the CGCN, several speakers reported on how religious liberty is under assault in the Middle East and in various nations of the world. In reflecting on the two day meeting, EA National Minister Jim Barnes said, "It's so easy for Christians in the West to lose perspective when we use the term 'persecution.' Here in the United States, we Christians get upset and sometimes say we're being persecuted when our friends and neighbors make disparaging remarks about our faith. We need to put all of that in perspective as we remember our brothers and sisters around the world who are literally losing their lives for the Lord."

He designed His church to be led by people with leadership gifts, taught by people with teaching gifts, shepherded by people with shepherding gifts, healed by people with discerning gifts, and administrated by people with administrative gifts. It is such a neat plan, and where churches have taken hold of it, it is bearing fruit.

We are a family on a mission: to gather others, to give life, to encourage, and to go forward with the ministry of Jesus. ## The "Boy" Pastor and His Call to Five Churches (at the same time!)

The Rev. Wayne Wright - Mt. Olivet Christian Church, Elkton, Virginia

It was the late 1950s and Wayne Wright was a high school student called to ministry. With a license to preach from the Methodists, Wayne was referred to by many of the parishioners in the four churches he served while still in high school as the "boy" preacher. When asked how he could serve as pastor of four churches at the same time, Wayne explained, "One of the churches had a Sunday night service and in the others I preached every other Sunday morning." Following his graduation from high school in 1958, Wayne increased his responsibilities to five Methodist churches that were his sole responsibility;

however you do the math, Pastor Wayne was preaching at three to four services every single Sunday.

In 1960, Wayne married his wife Joyce and set off on a career selling life insurance. During his 40 years with Met Life, he worked as a regional sales manager, all the while remaining involved in bivocational ministry serving as pastor of various churches. His ministry to Mount Olivet UCC began in 1982 when the church worship attendance was around 30 people on a Sunday morning. According to Wayne, "Seven of the thirty who showed up for church back in those days came in my car - my wife, our five kids and me."

Although members of the congregation had called Wayne to serve as their new pastor, some of the denominational leaders seemed uninterested in having him take the position. "I believe they simply intended to let the church go out of business," stated Pastor Wayne, "however they finally stopped resisting and one denominational leader even said, "We'll be closing the doors of that church in six months anyway.""

At age 75, Rev. Wayne Wright still serves as the pastor of Mt. Olivet Christian Church which averages between 130-150 in worship each Sunday. He was ordained by the congregation on September 27, 2009.

The church itself was formed in 1899 under the leadership of Rev. W.T. Herndon who was a native of Chatham County, North Carolina. Herndon began his ministry as an ordained elder in the Christian

church and staff member at Elon College.



During the 1930's the church participated in the merger with the Congregationalists and the name of the church became Mt. Olivet Congregational Christian Church. In the late 1950's they became part of the United Church of Christ and in 2008 they departed from the UCC. Shortly thereafter the congregation joined the Evangelical Association.

## **Church Planting in Cajun Country**

The Rev. Paul T. McHenry III

Paul McHenry grew up "everywhere" as a self-proclaimed military brat. Following in the family tradition, he became a naval officer as a young man and was deployed. While serving on board a ship, he was approached by the captain one day who noticed that he was the only officer who regularly attended church. After making this observation, the senior officer said, "You will be in charge of the Protestant services on board since we have no chaplain." With that, Paul's call to ministry was initiated.

After leaving military service, Paul enrolled at Reformed Theological Seminary where he received his divinity degree and began serving in various congregations affiliated with the

*Trinity ER Church storefront and Pastor McHenry* Presbyterian Church in America. In 2002, while living and working in Atlanta, he began dating a woman who would eventually become his wife. It just so happened that she lived in Cottonport, Louisiana.

Phil moved to Cottonport to get married and then began a new career as a middle and high school Social

Studies teacher in the local public system. While teaching teens, he also continued ministry work by serving as bi-vocational pastor of a small Presbyterian church in a nearby community.

In recent years, Pastor McHenry began to sense that God was calling him to plant a Reformed church in a parish in Louisiana with very few Protestant churches. In September of 2014 he and a small group of believers began renting a storefront in the center of the town to conduct Thursday night Bible studies and Sunday evening services.

Through his work with the public school system, one of the dreams Pastor Paul has for the church is that the Lord would call some young people with a missionary heart from nearby Christian colleges to come to the area to serve as school teachers (the rural community desperately needs qualified full-time teachers). These young teachers would then have the means to live in the community and minister to the unreached.
